PUBLICATION ETHICS AND PUBLICATION MALPRACTICE

The Cambridge Business & Economics Journal (CBEJ) is committed to upholding the highest standards of publication ethics and takes all possible measures against plagiarism and any publication malpractices. In the same manner, the CBEJ journal is committed to prevent any actual or potential conflict of interests between the editorial and review personnel and the reviewed material. Any departures from the above-defined rules should be reported directly to the Editors-in-Chief, who is unequivocally committed to providing swift resolutions to any of such a type of problems.

CBEJ's "publication ethics and publication malpractice" consists of these sections: Plagiarism, Responsibilities of Editors/Co-Editors/Editorial Boards, Responsibilities of the Reviewer, Responsibilities of Authors, Publication Process

PLAGIARISM

- All authors submitting their works to the CBEJ for publication as original articles attest that the submitted works represent their authors' contributions and have not been copied or plagiarized in whole or in part from other works.
- Authors explicitly identify, credit, and reference the author of any data or material taken verbatim from written work, whether that work is published, unpublished, or electronically available.
- Authors explicitly cite others' work and ideas, including their own, even if the work or ideas are not quoted verbatim or paraphrased. This standard applies whether the previous work is published, unpublished, or electronically available;
- Word-for-word copying of the work by others must be clearly identified. Short segments (a few words to one or two sentences) must be put in quotes or italicized; longer segments (e.g. a paragraph) should be indented or italicized. In both cases, the quoted work has to be followed by a citation, which may be a URL. This does not apply to casual phrases that do not convey original content (e.g. "This paper makes the following contributions"). Extensive copying of the work of others, even if clearly indicated, is generally not allowed.

RESPONSIBILITIES OF AUTHORS

1. Authors adhere to the highest ethical standards when participating in publication process and disseminating their research findings, such as in CBEJ or at the annual global conference;
2. Authors do not fabricate data or falsify results in their publications or presentations;
3. Authors take particular care to present relevant qualifications to their research or to the findings and interpretations of them. Authors also disclose underlying assumptions, theories, methods, measures, and research designs that are relevant to the findings and interpretations of their work;
4. If authors discover significant errors in their publication or presentation of data, they take

appropriate steps to correct such errors in the form of a correction, a retraction, published erratum, or other public statement;

5. Authors report sources of financial support in their papers and note any special relations to any sponsor. Authors may withhold the names of specific sponsors if they provide an adequate and full description of the sponsor's nature and interest;
6. Authors ensure that authorship and other publication credits are based on the scientific or professional contributions of the individuals involved;
7. Authors take responsibility and credit, including authorship credit, only for work they have actually performed or to which they have contributed;
8. In cases of multiple authorship, Authors confer with all other authors prior to submitting work for publication, and they establish mutually acceptable agreements regarding submission;
9. In submitting a manuscript to CBEJ, authors grant that publication first claim to publication except where explicit policies allow multiple submissions;
10. When authors publish data or findings that overlap with work they have previously published elsewhere, they have to cite these publications.

RESPONSIBILITIES OF EDITOR/CO-EDITORS/EDITORIAL BOARD

- Editor/Co-Editor/Editorial Board (hereinafter Editor) are fair in the application of academic publishing standards, and they operate without personal or ideological favoritism or malice. As editors, authors are cognizant of any potential conflicts of interest;
- Editor ensures the confidentiality of the review process and supervise editorial office staff, including students, in accordance with practices that maintain confidentiality;
- Editor is bound to publish all manuscripts accepted for publication unless major errors or ethical violations are discovered after acceptance (e.g., plagiarism and/or publication malpractice);
- Editor ensures the anonymity of reviewers. Editors ensure that their staff members conform to this practice;
- Editor ensures the anonymity of authors unless and until a manuscript is accepted for publication;
- Editor takes steps to provide for the timely review of all manuscripts and respond promptly to inquiries about the status of a review;
- It is an Editor policy to permit manuscripts that have been previously published in any proceedings to submit substantially embellished manuscripts for CBEJ review.

RESPONSIBILITIES OF REVIEWERS

- In reviewing material submitted for publication or other evaluation purposes, reviewers respect the confidentiality of the process and the proprietary rights of those who submitted the material;
- Reviewers disclose conflicts of interest or decline requests to review others' work when they are aware of conflicts of interest;

- Reviewers decline requests for reviews of the work of others when they believe that the review process may be biased or when they have questions about the integrity of the process.
